

GOODY'S "THE WALL" VICTORY JUNCTION FACEBOOK SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE ONE'S CHANCE OF WINNING. SWEEPSTAKES VOID WHERE PROHIBITED BY LAW.

1. HOW TO ENTER: To enter the Goody's "The Wall" Victory Junction Facebook Sweepstakes ("Sweepstakes") visit <<http://www.facebook.com/goodyspowder>> and enter thru the Goody's application ("Application") on the Facebook platform. (You must "Like" the Goody's Page prior to submitting entry). Entrants are required to complete the following information: title, first name, last name, year of birth, zip code, email, password, complete mailing address and phone number. PO Boxes are not permitted. Odds of winning depend on the number of eligible entries received. Entries become the property of the Sponsor, and will not be acknowledged or returned.
